PRIVACY INFORMATION PURSUANT TO ART. 13 OF THE EUROPEAN REGULATION 679/16 (GDPR) FOR THE PROCESSING OF PERSONAL DATA

The processing will be carried out with manual and computerized and telematic tools in compliance with the rules in force and the principles of correctness, lawfulness, transparency, relevance, completeness and non-excess, accuracy and organization and processing logic strictly related to the objectives pursued. and in any case in such a way as to guarantee the security, integrity and confidentiality of the data processed, in compliance with the organizational, physical and logical measures provided for by the provisions in force.

5. Purpose of the treatment

a) Allow browsing on this website and the technical management of connections to it.

c) Follow up requests for offers made by customers / users about the services offered by the Data Controller and for all activities always linked to sending the estimate.

6. **Dissemination**, Possible recipients or categories of recipients of data

No data will be disseminated in any way.

The data provided will be processed exclusively by persons authorized to process and appropriately trained, as well as by data controllers linked to the holder by a specific contract, for example: companies that provide services for the management of the IT system and telecommunications networks.

The updated list with the identification details of all the Data Processors may be requested by the Data Controller at any time.

However, the data will not be transferred outside the EU territory.

We also inform you that you have the right to withdraw your consent to the processing of your data at any time, without prejudice to the lawfulness of the processing based on the consent given before the revocation (Article 7, paragraph 3 of the GDPR).

Pursuant to art. 77 of the Rules of Procedure, you are granted the right to lodge a complaint with a supervisory authority, particularly in the Member State in which you are habitually resident.
